DEPOSIT FOR FUTURE KITTEN?	

Deposit is non-refundable if purchaser is unable, or decides not, to take the kitten. The deposit may, however, be applied to another available kitten should the original kitten become unfit for sale, or buyer is unhappy with the kitten's development. The **remaining balance** is due at pick-up of kitten or if being shipped due before shipping (shipping costs are extra and are also due before shipping). Remaining balance must be paid in guaranteed funds (cash/money order/bank transfer).

Health records and a care sheet are provided at the time of sale.

CONDITIONS OF SALE:

HEALTH GUARANTEE

Health is guaranteed for a period of 72 hours from the time the kitten leaves the possession of the Seller if vetted within that time (at Buyer's expense). Failure to have animal checked by a licensed veterinarian within 72 hours will void any guarantee. The kitten/cat **MUST** be quarantined and have no contact with other animals during that 72-hour period. If the cat/kitten is found after such examination to have any type of life threatening problem, it may be returned and a replacement kitten offered as available. Seller will not honor any health guarantee if the kitten/cat dies of a virus from contact with another animal not bred at this Cattery.

CONGENITAL DEFECTS

This kitten/cat is guaranteed against congenital defects for two years from date of sale. Should the animal die within that time as a direct result of a congenital defect, the cat will be replaced **ONLY** if an appropriate necropsy is performed by a licensed veterinarian and a veterinarian's certificate is provided as proof of cause of death. The kitten/cat can not be returned for compensation after the guaranteed period has expired. **NO KITTEN OR CAT IS TO BE EUTHANISED WITHOUT THE PRIOR KNOWLEDGE OF THE BREEDER, EXCEPT IN THE CASE WHERE A VETERINARIAN CONSIDERS IT THE ONLY HUMANE ALTERNATIVE, OR THE GUARANTEE IS VOID.**

REPLACEMENT CAT/KITTEN

A replacement will be made of a kitten/cat of comparable quality and value, as available, at the discretion of Seller. If no replacement is available at the time of return, Seller will have up to one year to furnish a comparable kitten/cat. No replacement will be given for any condition or defect caused by accident, neglect or malnutrition. Where a replacement is requested and where euthanasia is required, Buyer agrees to grant full access to all veterinary records to Breeder. Veterinary records include copies of actual visit cards to veterinarians stating vaccinations, injuries, test results, etc. during the period the kitten is owned by the Buyer.

OTHER

- * Buyer agrees that this guarantee of health and temperament is void if the Buyer has the cat/kitten declawed, been allowed outside unsupervised, or vaccinated for FIP. Any conditions caused by vaccinating with a modified live vaccine will not be covered.
- * The purchaser agrees to keep the kitten/cat indoors at all times unless in a carrier, on a leash and accompanied at all times by a competent handler, or in an escape proof enclosure.
- * If the cat/kitten is returned to said Breeder for any reason, the cat/kitten must be vet tested for FeLV and FIV at the Buyer's expense.
- * Kittens are not guaranteed to be hypoallergenic - please test for allergies before getting a kitten if you are unsure.
- * Once the cat/kitten leaves the possession of the Breeder, said Breeder cannot be held responsible for any veterinary bills or charges incurred on said cat/kitten.

Buyer agrees and binds him/herself to take good and reasonable care of this cat/kitten so as to provide food, water, shelter, correct routine and accident related medical care, exercise and affection. Buyer agrees to provide immediate veterinary care to this kitten/cat if it shows signs of distress, illness, or injury. Failure to do so will render the guarantee null and void. Buyer agrees that if the kitten/cat is found to be neglected or mistreated, Seller shall have the unconditional right to reclaim the kitten/cat WITHOUT refund of purchase price. Buyer will be responsible for any veterinary bills directly incurred as a result of any neglect or mistreatment.

Buyer agrees that under NO circumstances will the kitten/cat EVER be sold, leased, or given to any pet shop, animal shelter, research laboratory, or similar facility. Furthermore, it is agreed that transfer of possession, or care of the kitten/cat to another party may only be done with express written permission of Seller. Should Buyer not be able to keep this animal for any reason, including the incapacitation or death of the Buyer, it is to be returned to Breeder/Seller for placement without refund of any kind, unless the above written permission to transfer ownership is obtained. If such permission is given, new owner must sign a new contract, identical or similar to this one, with Breeder/Seller. Buyer agrees to tell family members about this clause.

This Contract is legally binding to all parties involved. It applies only to the Buyer and Wendy Basham (Summerside Bengals) in this transaction and is non-transferable to other parties. Any legal action which may arise under the terms of this contract will be brought in Kitchener, Ontario. Buyer shall be liable for any court costs and related charges including attorney's fees associated with Seller enforcing the terms of this contract.
